Proceedings:

The meeting commenced at 11:00 AM under the chairmanship of Dr. Somadatta B. Karanjekar. The Member Secretary welcomed all the members and presented the agenda items for discussion.

Agenda Item 1: Confirmation of previous meeting minutes.

The minutes from the previous GRC session were formally reviewed before the meeting began. To enable a comprehensive audit of the recorded talks and prior action items, these papers were distributed via email to every committee member well in advance. The committee moved to formally adopt the documents following a brief floor discussion during which no errors or omissions were pointed up. This procedure preserves the administrative integrity of the committee's operations by guaranteeing that all ensuing judgments are based on a verified and signed historical foundation.

Resolution No. 1: The Chairperson unanimously approved and signed the minutes of the prior meeting. The committee reiterated that the records provide a strong basis for the current agenda by correctly reflecting the conversations and choices made.

The "Induction Mandate": It is resolved that a **15-minute GRC Orientation** shall be mandatory for all first-year students. This session must introduce the Committee members by name and face to humanize the process.

Agenda Item 4: Instructions given to mentors regarding the student complaint process.

To standardise mentors' advice so that all students understand how to use the grievance redressal mechanism.

Resolution No. 4:

It was resolved that an obligatory training regarding the formal complaint feeling procedure should be given by all mentors to their respective mentee groups.


Agenda Item 5: The faster response methods for future issues.

To establish a clear framework for resolving student grievances increase institutional efficiency.

Resolution No. 5:

Be it resolved that shall implement an Accelerated Response Framework to streamline student grievance procedures. This initiative will centralize communication channels, mandate specific response timelines, and utilize data-driven tracking to increase institutional efficiency and restore student trust.

The meeting commenced at 11:00 AM under the chairmanship of Dr. Somadatta B. Karanjekar. The Member Secretary welcomed all the members and presented the agenda items for discussion.

Agenda Item 1: Mentors were advised to strengthen communication and monitor attendance issues.

Review of current student engagement levels and identified gaps in mentor-student touchpoints.

Resolution No. 1:

It is hereby resolved that every mentor shall conduct a minimum of **one face-to-face or virtual group interaction per fortnight** to address student concerns. Mentors are advised to use empathetic, clear, and multi-channel communication to ensure no student feels "unheard."

Agenda Item 2: A workshop on Gender Sensitization and Harassment was proposed.

The committee discussed strategies to bridge the awareness gap between students and staff regarding gender-based issues, emphasizing a **"preventative" communication model** rather than a strictly

"redressal" approach. To achieve this, a **Workshop on Gender Sensitization and Harassment** was proposed as a means to demystify the Internal Committee's role and foster a safer campus climate.

Resolution No. 2:

Resolved that the proposal to conduct a mandatory workshop on Gender Sensitization and Harassment for all employees/staff members and students of Wainganga College of Engineering and management be and is hereby approved

Agenda Item 3: To co-ordinate between students and department to redress the grievances.

Review of unresolved student issues from the previous month and identifying departmental bottlenecks.

Resolution No. 3:

It is hereby resolved that each department shall designate a **Liaison Officer** to whom mentors can directly escalate unresolved student grievances. This bypasses generic helpdesk delays.

Agenda Item 4: To guide ways and means to the students to redress their problems.

This agenda and resolution focus on empowering the students. Instead of the mentor doing all the heavy lifting, the goal here is to give students the "map and compass" they need to navigate the institutional hierarchy effectively.

Resolution No. 4:

Mentors are resolved to provide a form to students. This ensures that student complaints are professional, clear, and actionable, reducing the "back-and-forth" caused by vague grievances.
